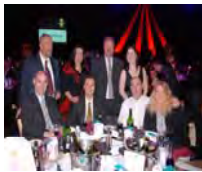




Dear SISA member,

Overview

The Self Insurers of South Australia (SISA) represents South Australia's largest private sector employers and the public sector, totalling 36% of the State's workforce by remuneration.
