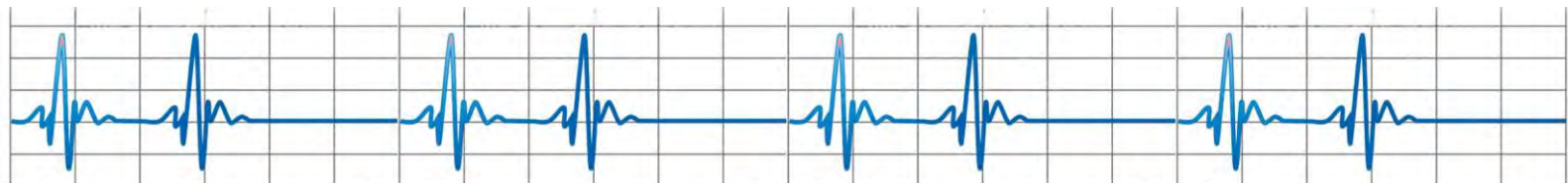

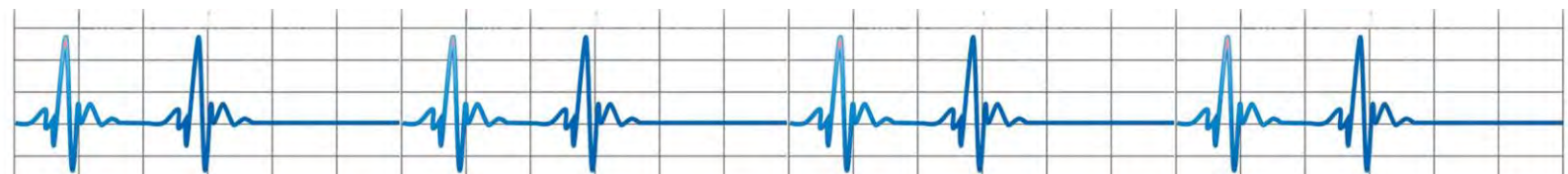

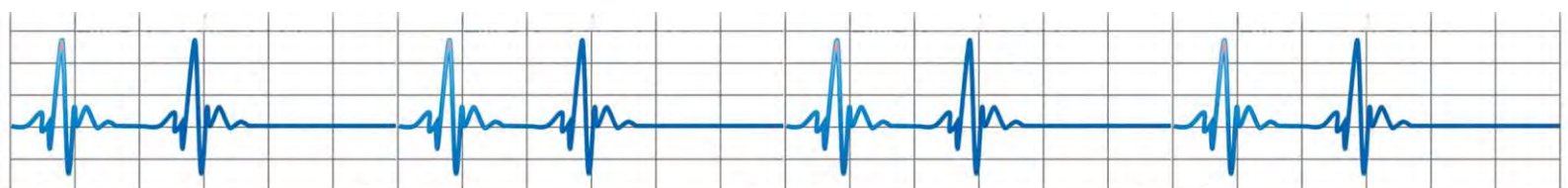
Speaker: Amanda Blair

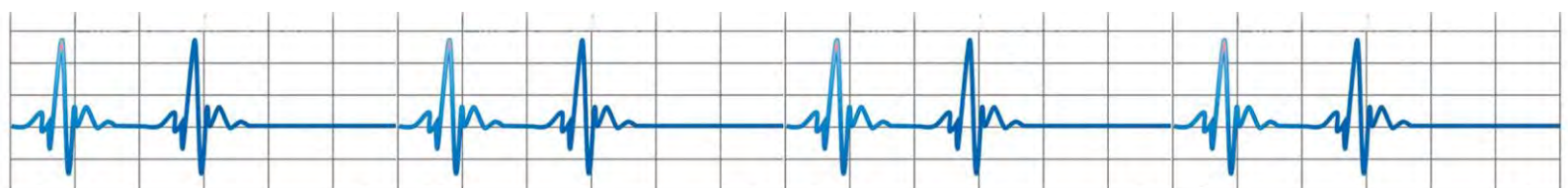
Christopher Hamilton

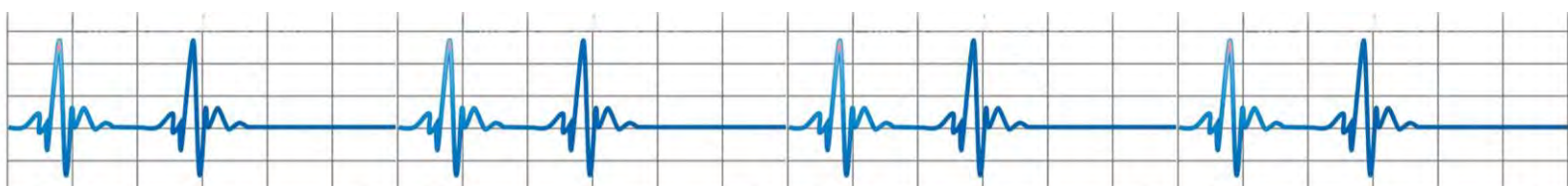

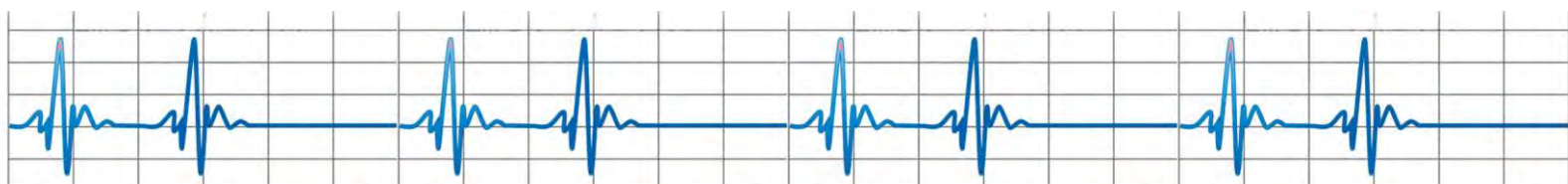

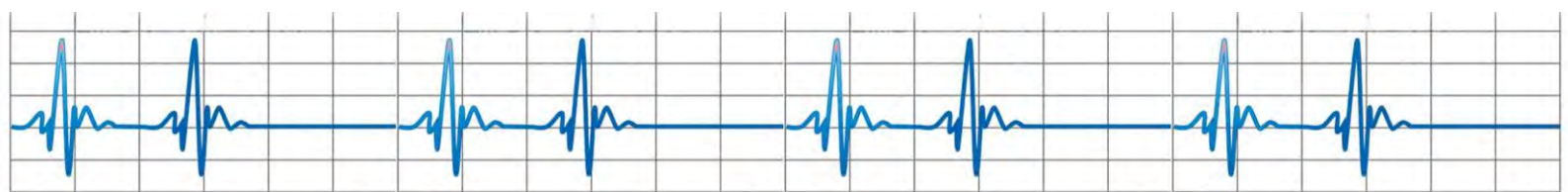
