

SISA Update February 2016

- Greg McCarthy to retire late 2016
- Rob Cordiner (current GM Insurance) to take over as CEO
- Michael Francis to be GM Insurance
- Julia Oakley (currently GM Corporate Services) to be GM Scheme Improvement and Regulation



- Increase min guarantee from \$840K to \$4.5m:
 - Would require an amended regulation (Schedule 3 clause (6)), so is subject to disallowance
 - Based on what SISA sees as very poor reasoning
 - Would cause serious financial damage to some members
 - Fund is already far better protected than any other:
 - 200% scaling factor on guarantees
 - EOL reinsurance
 - \$50 million in insolvency aggregate



- The reasons make no sense at all:
 - Catastrophic injury claims somehow create increased risk under RTWA due to lack of ability to redeem medicals
 - How would they know how SIs would deal with such claims? This is guesswork disguised as prudence!
 - Service standards create increased risk
 - We will see what Wayne Lines says about that!



- Employee head-count:
 - Is a poorly disguised blunt instrument to choke off self-insurance
 - Unsustainable argument that employee numbers ensure proper resourcing of claims management
 - Statements that a self-insurer with a small claim portfolio will cut RTW resources & breach Act by non-payment - insulting and fly in the face of history
 - Regardless of the rationale, such a policy is unlikely to be found lawful if it is used to justify rejection



- The results of this irresponsible attack:
 - RTWSA might gain a 2%-3% increase in premium income a drop in the ocean
 - Level of self-insurance might drop by a similar margin – big deal!
 - Scheme no better protected
 - In return risk of plant closures, offshoring, job losses
 - Is SA really open for business??
 - Likely to be some media interest and possible reputation damage – SISA can't control that



• Situation as it stands:

- Meetings held with Greg McCarthy and Michael
 Francis plenty of fencing but not much agreement
- SISA has asked for Board's detailed reasoning actuarial, financial advice so we can respond
- Doubt that it even exists
- RTWSA suggesting there might be a negotiated solution; but -
- SISA will not negotiate to the detriment of its members or their workforces



- Situation as it stands (cont)
 - Proposed meeting with the RTWSA Board mid-March
 - Letters from members outlining damage gone to MIR, Treasurer, other Ministers, RTWSA
 - Member MDs & CEOs meeting with MIR, Board Chair etc
 - Need as many getting active as we can get
 - We can win if pressure is sufficient
 - Media has the story



Observations

- Management says it is all driven from the Board
- That would be remarkable an artful dodge?
- If the 'experts' giving the advice are also Board members, they are conflicted
- Things have been as is for decades. Why 'fix' it?
- Only case of loss caused by insolvency O'Connor Engineering (late 80s) - before guarantees
- Financial incentives didn't work so out come the blunt instruments!



Return to Work Act 2014

- *Walmsley* (s.18(3)) trial still under way
- Otherwise still not much by way of precedents
- New decision published *RTWSA (Scania Australia Pty Ltd) v Juett [2016] SAET1*
- Medical-only claims cease benefits in June
- Ongoing high levels of redemption activity by RTWSA
- Still no news re the ATO position on income redemption



Other news

- Occupational Licensing National Law (South Australia) Repeal Bill – part of a COAG decision to abolish the national licencing regime and seek a less restrictive system. Tabled 11/2/16
- Parliamentary Standing Committee on OHS & Rehab is examining the industrial manslaughter Bill – TOR on SISA website



Other news

- Issue with SA Police has been resolved via changes to the enterprise agreement
- That was always the smart way. EBAs and awards exist to differentiate working conditions between occupations
- Presumably the Bill will be withdrawn
- But the genie is out of the bottle
